This pertains to the Memorandum dated February 23, 2016 of Deputy Executive Director for Operations Bartolome J. Sinocruz, Jr. relative to the Memorandum of EBAD Director Teopisto E. Elnas, Jr., on the various requests for inclusion in the list of voters of several municipalities.

The Memorandum of Director Sinocruz reads:

*"This refers to the hereto attached Memorandum dated February 4, 2016 of EBAD Director Teopisto E. Elnas, Jr., together with the pertinent documents, which refers to several requests for inclusion in the list of voters by Election Officers of several municipalities for various reasons stated therein.*

*Considering that the non-inclusion of the names of voters found to be with corrupted biometrics data and those erroneously deleted would result to undue deprivation of their right of suffrage in the May 9, 2016 National and Local Elections, Director Elnas recommended the inclusion of the hereunder named voters in the list of voters of the following municipalities:*




