[MUSLIM MINDANAO AUTONOMY ACT NO. 52]

AN ACT CREATING THE MUNICIPALITY OF TALITAY IN THE PROVINCE OF MAGUINDANAO, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. The barangays and all the sitios found in these respective barangays of Talitay, Kilalan, Gadungan, Manggay, Pageda, Kiladap, Kuden, Adaon, Mapayag, Bintan, Tugal, Nunangan, and Macadayon in the Municipality of Talayan, Province of Maguindanao are hereby created to be known as the Municipality of Talitay.

SEC. 2. The Seat of the Municipal Government of the Municipality of Talitay shall be in Barangay Talitay.

SEC. 3. The Municipality of Talitay shall be bounded on the North west by the natural boundary of the Municipality of Datu Odin Sinsuat and Talitay along the Brar creek by lines 1-2 which is approximately 2.80 kms; lines 2-3 which is approximately 1.30 kms; lines 3-4 which is approximately 3.20 kms at the junction of Brar Creek and Butelen creek on point 4; On the North east by the natural boundary of the municipalities of Datu Piang and Talitay along the Butelen creek by lines 4-5 which is 3.0 kms; lines 5-6 which is 1.55 kms; lines 6-7 which is 0.40 km; lines 7-8 which is 0.75 kms; On the South East along the Matalam road by lines 8-9 which is 0.90 km; lines 9-10 which is 0.95 km; lines 10-11 which is 1.0 km; lines 11-12 which is 0.60 km; lines 12-13 which is 1.40 kms and on point 13 towards the South west by lines 13-14 which is 0.80 km and on point 14 towards the Highway by lines 14-15 which is 0.35 km; and point 15 along the highway towards lines 15-1 which is approximately 2.50 kms, with a total land area of 65.19 square kilometers, more or less.


SEC. 4. The Commission on Elections shall conduct and supervise the plebiscite which shall be held thirty (30) days after the approval of this Act. Upon ratification by the majority of votes cast in the plebiscite held in the area affected, the Regional Governor of the Autonomous Region in Muslim Mindanao shall appoint the Mayor, Vice-Mayor and Members of the Sanggunian Bayan of the new Municipality of Talitay who shall hold office until their successors shall have been duly elected in the next general elections for the local officials and shall have qualified.

SEC. 5. The Municipality is a corporate entity with jurisdiction in all matters provided by Muslim Mindanao Autonomy Act No. 25 and other pertinent existing laws.


SEC. 6. The expenses in holding the plebiscite for the purpose shall be drawn out of any available funds in the Regional Treasury and not otherwise appropriated as may be authorized by the Regional Governor.

SEC. 7. This Act shall take effect upon its approval.
