[ MUSLIM MINDANAO AUTONOMY ACT 80 ]

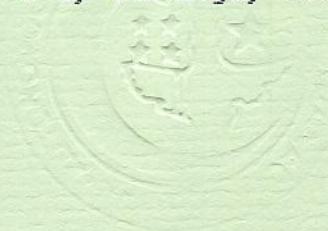
"AN ACT CREATING BARANGAY PATPANGKAT II IN THE MUNICIPALITY OF SAGUIARAN, LANA DEL SUR AND FOR OTHER PURPOSES."

Be it enacted by the Regional Legislative Assembly in session assembled.

SECTION 1. Barangay Patpangkat II is hereby separated from its mother unit, Barangay Patpangkat I in the Municipality of Saguiaran, Province of Lanao del Sur and constituted into a distinct and independent barangay.

SEC. 2. The territorial jurisdiction of Barangay Patpangkat II contains an area of Two Hundred Seventy Two point Three Thousand Eight Hundred Fifty Seven (272.3857) Hectares which is defined, as follows:

"Bounded on the South along line 1-2 by Barangay Cadayonan; on the West along line 2-3 by Municipality of Piagapo, Lanao del Sur, on the North along line 3-4 by Sitios Pacal, Poblacion and Panati; and on the East along line 4-1 by Barangay Maliwanag."





"Beginning at a point marked "1" on the map being N39-11W; 3,571.06 meters from BLLM No. 1, Triangulation Saguiaran, Thence: S89-20W, 2,501.34 meters to point 2; N04-02W, 1,185.37 meters to point 3; N85-42E, 1,851.25 meters to point 4; S29-45E, 1,488.29 meters to point of beginning.."

SEC. 3. The Sangguniang Barangay shall, taking into consideration accessibility and centrality, determine and fix the seat of government of Barangay Patpangkat II..

SEC. 4. Immediately after the ratification of this Act, the punong barangay and seven (7) members of the sangguniang barangay shall be appointed by the mayor of Saguiaran Municipality; while the chairman and seven (7) members of the sangguniang kabataan shall be appointed by the concerned punong barangay: Provided, That they shall hold office until their successors shall have been duly elected and qualified in their next sangguniang regular elections: Provided, Further, That they shall exercise their duties and powers specified under Republic Act 6734, Muslim Mindanao Autonomy Act 25, and other existing rules and regulations..

SEC. 5. The corporate existence of Barangay Patpangkat II shall commence upon the appointment and qualification of the punong barangay and a majority of the sangguniang members..

SEC. 6. The sangguniang bayan shall provide for the necessary allowances and other benefits of the appointed barangay officials out of the municipal funds until the regular allocation from the national government shall have been released to the new barangay..


SEC. 7 The Commission on Elections shall conduct and supervise the plebiscite which shall be held within ninety (90) days after the approval of this Act..

SEC. 8. The expenses required for the plebiscite shall be appropriated out of any available funds in the treasury of the municipality of Saguiaran as may be determined by its sangguniang bayan..




SEC. 9. This Act shall take effect upon its approval.
