EXECUTIVE ORDER }
No. 100. }

Pursuant to the provisions of Act Numbered Six hundred and forty-eight, Philippine Commission, entitled "An Act authorizing the Governor-General to reserve for civil public purposes, and from sale or settlement, any part of the public domain not appropriated by law for special public purposes, until otherwise directed by law, and extending the provisions of Act Numbered Six hundred and twenty-seven so that public lands desired to be reserved by the Insular Government for public uses, or private lands desired to be purchased by the Insular Government for such uses, may be brought under the operation of the Land Registration Act," I hereby reserve for school purposes and withdraw from sale or settlement the following described parcels of public domain in the barrio of Bua, municipality of Itogon, Mountain Province, Island of Luzon, to wit:

Parcel 1.

Beginning at point marked 1 on plan II-6676, N. 84° 31' W. 551.4 m. from B. L. Monument No. 1, Bua, thence N. 25° 09' W. 120.42 m. to point 2; N. 29° 37' W. 156.84 m. to point 3; S. 73° 44' E. 368.28 m. to point 5; S. 57° 41' W. 266.07 m. to point 1, point of beginning.

Containing 35,997 square meters.

All points are marked by P. L. S./B. L. concrete monuments.

Bounded on northeast by Madalay mineral claim (J. E. Kelly) and property of J. E. Kelly; on southeast by lot 3; on southwest by Madalay mineral claim (J. E. Kelly).

Parcel 2.

Beginnining at point marked 1 on plan II-6676, N. 87° 06' W. 533.26 m. from B. L. Mon. No. 1, Bua, thence S. 26° 02' W. 83.02 m. to point 2; S. 37° 57' E. 25.79 m. to point 3; N. 88° 04' E. 78.98 m. to point 4; N. 32° 19' W. 109.18 m. to point 1, point of beginning.

Containing 4,681 square meters.

All points are marked by P. L. S./B. L. concrete monuments.

Bounded on northeast by lot 3; on south, southwest, and northwest by Moon mineral claim (J. E. Kelly).

Parcel 3.

Beginning at point marked 1 on plan II-6676, S. 70° 17' W. 173.85 m. from B. L. Mon. No. 1, Bua, thence N. 32° 19' W. 300.0 m. to point 2; S. 57° 41' W. 266.07 m. to point 3; S. 32° 18' E. 30.48 m. to point 4; S. 32° 19' E. 109.18 m. to point 5; S. 32° 19' E. 160.35 m. to point 6; N. 57° 41' E. 266.06 m. to point 1, point of beginning.

Containing 79,815 square meters.

All points are marked by P. L. S./B. L. concrete monuments.

Bounded on northeast by Star mineral claims and Alaska mineral claim (P. J. O'Neill); on southeast by Alaska mineral claim (P. J. O'Neill) and property of J. E. Kelly; on southwest by property of J. E. Kelly, Moon mineral claim (J. E. Kelly), and lot 2; on northwest by lot 1.

Bearings true. Declination, 0° 26' E.

Points referred to marked on plan II-6676.

Parcel 4.

Beginning at point marked 1 on plan II-7917, N. 39° 17' W. 1,618.3 m. from B. L. M. No. 1, Bua, thence N. 49° 29' W. 130.0 m. to point 2; N. 60° 13' E. 56.02 m. to point 3; S. 45° 23' E. 88.91 m. to point 4; S. 4° 33' E. 30.84 m. to point 5; S. 39° 05' W. 24.63 m. to point 1, point of beginning.

Containing 5,677 square meters.

All points are marked by P. L. S./B. L. concrete monuments.

Bounded on all sides by public land.

Bearings true. Declination, 0° 23' E.
