EXECUTIVE ORDER }
No. 40. }

Pursuant to the provisions of Act Numbered Six hundred and forty-eight, Philippine Commission, entitled "An Act authorizing the Governor-General to reserve for civil public purposes, and from sale or settlement, any part of the public domain not appropriated by law for special public purposes, until otherwise directed by law, and extending the provisions of Act Numbered Six hundred and twenty-seven so that public lands desired to be reserved by the Insular Government for public use, or private lands desired to be purchased by the Insular Government for such uses, may be brought under the operation of the Land Registration Act," I hereby reserve for provincial park purposes and withdraw from sale or settlement the following-described parcel of public domain in the barrio of Naga, municipality of Tiwi, Province of Albay, Island of Luzon, to wit:

Beginning at point marked 1 on Plan II-6679, S. 66° 40' W. 402.04 m. from B. L. B. M. No. 1, Barrio of Naga, thence N. 47° 33' W. 250.53 m. to point 2; N. 41° 13' E. 528.48 m. to point 3; N. 79° 20' E. 623.67 m. to point 4; S. 63° 09' E. 255.57 m. to point 5; S. 25° 41' W. 569.62 m. to point 6; N. 63° 47' W. 394.66 m. to point 7; N. 85° 21' W. 190.98 m. to point 8; S. 41° 13' W. 323.27 m. to point 1, point of beginning.

Containing 440,530 square meters.

Points 1, 2, 3, 5, 6, 7, and 8 are P. L. S./B. L. monuments; point 4, bamboo.

Bounded on northeast by properties of Facundo Competente, Catalino Brosola, Eustaquio Crosa, and Abdon Dacilio; on southeast by properties of Abdon Dacilio, Alfonso Toledo, Fabian Dacoba, Perfecto Cortesano, Leon Zaens, and Andres Arimbay; on southwest by properties of Andres Arimbay, Basilio Dacame, Claro Borromeo, Vicente Catorce, Sabina Competente, Jovencia Bosquet, Perfecto Bosquet, Gregorio Claudio, Matias Carbonell, Alfonsa Toledo, Silvino Dacoco, and Juan Cubilla; on northwest by properties of Alfonsa Toledo, Vicente Catorce, Abdon Dacilio, Juan Combo, Pantaleon Ascune, Ana Bron, and Facundo Competente.

Bearings true. Declination, 1° 03' E.
