EXECUTIVE ORDER }
No. 93. }

Pursuant to the provisions of Act Numbered Six hundred and forty-eight, Philippine Commission, entitled "An Act authorizing the Governor-General to reserve for civil public purposes, and from sale or settlement, any part of the public domain not appropriated by law for special public purposes, until otherwise directed by law, and extending the provisions of Act Numbered Six hundred and twenty-seven so that public lands desired to be reserved by the Insular Government for public uses, or private lands desired to be purchased by the Insular Government for such uses, may be brought under the operation of the Land Registration Act," I hereby reserve for coal yard purposes and withdraw from sale or settlement the following described parcel of public domain in the municipality of Zamboanga, Moro Province, Island of Mindanao, to wit:

Beginning at point marked 1 on plan In-116, S. 37° 49' E. 561.5 m. from L. Mon. No. 9, thence N. 36° 06' E. 58.9 m. to point 2; S. 46° 19' E. 83.5 m. to point 3; S. 27° 56' E. 30.1 m. to point 4; S. 12° 01' E. 52.3 m. to point 5; S. 4° 23' E. 55.4 m. to point 6; S. 34° 31' W. 81.2 m. to point 7; S. 55° 29' W. 36.9 m. to point 8; N. 17° 19' W. 23.9 m. to point 9; N. 17° 19' W. 67.6 m. to point 10; N. 17° 19' W. 53.8 m. to point 11; N. 17° 19' W. 40.1 m. to point 12; N. 7° 43' E. 10.3 m. to point 13; N. 7° 43' E. 33.5 m. to point 14; N. 7° 43' E. 10.6 m. to point 1, point of beginning.

Containing 22,948 square meters.

Points 1, 8, and 12, P. L. S./B. L. monuments.

Bounded on northeast and southeast by sea; on southwest by properties of Albino Lim, Antonio Lim, and Enrique Lim; on northwest by properties of Enrique Lim, Dolores Lim, and Magdalena Lim.

Bearings true. Declination, 1° 50' E.

Points referred to marked on plan In-116.

Surveyed, January, 1909–July, 1910. Approved, September 11, 1913.

NOTE.—The above area consists of lots 127-B, 128-B, 129-B, 130-B, 131-B and 132-B of the Zamboanga Townsite, West Extension Cadastral Survey, as decreed in Court of Land Registration Cases 7885 and 8695.
