PROCLAMATION NO. 85

ESTABLISHING AS NATONIN - TANUDAN-TABUK FOREST RESERVE FOR WOOD PRODUCTION, WATERSHED, SOIL PROTECTION AND OTHER FOREST USES, THE PARCELS OF PUBLIC DOMAIN KNOWN AS TIMBERLAND, BONTOC (MT. PROVINCE) LAND CLASSIFICATION PROJECT NO. 10-A AND KALINGA (MT. PROVINCE) LAND CLASSIFICATION PROJECT NOS. 4-G AND 5-A, PER B.P. MAP L.C. 2144 (2 SHEETS), SITUATED IN THE MUNICIPALITY OF NATONIN, SUB-PROVINCE OF BONTOC, MT. PROVINCE AND MUNICIPALITIES OF TABUK AND TANUDAN, SUB-PROVINCE OF KALINGA, MT. PROVINCE, PHILIPPINES.

Upon recommendation of the Director of Forestry, approved by the Secretary of Agriculture and Natural Resources, and pursuant to the provisions of Section 1826 of the Revised Administrative Code, as amended by Republic Act No. 3092, I, FERDINAND E. MARCOS, President of the Philippines, do hereby withdraw from entry, sale, settlement, or other disposition, and establish as NATONIN-TANUDAN-TABUK FOREST RESERVE, subject to private rights, if any there be, the parcels of public domain known as Timberland, Bontoc (Mt. Province) Land Classification Project No. 10-A and Kalinga (Mt. Province) Land Classification Project Nos. 4-G and 5-A, situated in the Municipality of Natonin, Sub-Province of Bontoc, Mt. Province and Municipalities of Tabuk and Tanudan, Sub-Province of Kalinga, Mt. Province, denarcated and established under Forestry Administrative Order No. 4-662, dated September 16, 1957, for wood production, watershed, soil protection and other forest purposes under the administration and control of the Director of Forestry who shall have the authority to regulate the use and occupancy of said forest reserve and the cutting, collection, and removal of timber and other forest products therein in accordance with the forest laws and regulations.

The aforementioned parcels of public domain are shown and more particularly described in the attached Bureau of Forestry Map L.C.-2144 (2 sheets), comprising the Timberland of the aforementioned Bontoc (Mt. Province) Land Classification Project No. 10-A and Kalinga (Mt. Province) Land Classification Project Nos. 4-G and 5-A, containing an area of TWENTY THOUSAND ONE HUNDRED SIXTY TWO (20,162) HECTARES, more or less.
