PROCLAMATION NO. 265

RESERVING FOR RESETTLEMENT SITE PURPOSES OF THE MOUNT PINATUBO VICTIMS CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN LOCATED IN THE MUNICIPALITIES OF SAN CLEMENTE AND MAYANTOC, PROVINCE OF TARLAC, ISLAND OF LUZON

In consideration of the urgent need to assist the families affected by the eruption of Mt. Pinatubo by providing them with suitable resettlement and livelihood areas conducive to their economic recovery, and upon recommendation of the Secretary of Environment and Natural Resources and the Presidential Task Force created under Memorandum Order No. 369, dated June 26, 1991, now superseded with the creation of the Mt. Pinatubo Assistance Resettlement and Development Commission under Republic Act No. 7637 and by the powers vested in me by law, I, FIDEL V. REAMOS, President of the Philippines, do hereby reserve for resettlement and livelihood purposes, subject to private rights, if any there be, and to future classification and survey, certain parcels of land of the public domain situated in the Municipalities of San Clemente and Mayantoc, Province of Tarlac, Island of Luzon and more particularly described as follows:

PARCEL I

A PARCEL OF LAND (being a portion of Lot 4294, San Clemente Cad. 383-D, as shown in the attached Sketch Plan Sheet 1) situated in Barangay Maasin, Municipality of San Clemente, Province of Tarlac, Island of Luzon. Bounded on the South, along lines 1-3 and 37-39-1 by the Municipality of Mayantoc; on the Northwest, along lines 3-5 by the Municipality of Mangatarem, Province of Pangasinan; and on the North and East, along lines 5-37, by portion of Lot 4294, San Clemente Cad. 383-D. The lots within this Proclamation shall be disposed of through stewardship contract under the Integrated Social Forestry Program inasmuch as the area is presently classified as forest land, subject to appropriate modes of disposition under the Public Land Law, as amended, should there be a reclassification later.
