

BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO. 1151

ESTABLISHING AS JOSE PANGANIBAN WATERSHED FOREST RESERVE FOR THE PURPOSE OF PROTECTING, MAINTAINING OR IMPROVING THE WATER YIELD AND PROVIDING RESTRAINING MECHANISM FOR IN APPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-USE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF JOSE PANGANIBAN, PROVINCE OF CAMARINES NORTE, PHILIPPINES

Upon recommendation of the Secretary of Department of Environment and Natural Resources and pursuant to the powers vested in me by law, I, **FIDEL V. RAMOS**, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement, and set aside as Jose Panganiban Watershed Forest Reserve, subject to private rights, if there be any, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary, Department of Environment and Natural Resources, a certain parcel of the public domain located in the Municipality of Jose Panganiban, Province of Camarines Norte, Philippines, more particularly described as follows:

Thence following water pipeline generally Northerly direction, about 920 meters to corner 62; a point identical to corner 27, Timberland, under Project No. 2-G of Camarines Norte, L.C. Map No. 1862;

Thence N 06° 30' W, 230 meters to point of beginning containing an area of ONE THOUSAND ONE HUNDRED SIXTY (1,160) HECTARES, more or less.

The area covered by the reservation shall be under the administrative jurisdiction, supervision and control of the Department of Environment and Natural Resources, through its Forest Management Bureau, in coordination with other agencies of the government with the objective of maintaining its usefulness as a source of water for irrigation, domestic and other purposes. The conservation of water being of primary importance, all other uses of the forest are subordinated to that purpose.
