PROCLAMATION NO. 1259

REDEFINING THE RESERVED AREAS COVERED BY THE CAVITE EXPORT PROCESSING ZONE LOCATED IN THE MUNICIPALITIES OF ROSARIO AND GENERAL TRIAS, PROVINCE OF CAVITE

By virtue of the powers vested in me by law, and upon the recommendation of the Philippine Economic Zone Authority (PEZA), **I, FIDEL V. RAMOS**, President of the Philippines, do hereby further amend Proclamation No. 1980 (Reserving for Purposes of the Export Processing Zone Authority Parcels of Land of the Private Domain) dated May 30, 1980, as amended by Proclamation No. 2017 (Reserving Parcels of Land for the Cavite Export Processing Zone) dated September 19, 1980, by redefining the reserved areas of the Cavite Export Processing Zone situated in the municipalities of Rosario and General Trias, Province of Cavite, which are more particularly described as follows:


Any other executive acts inconsistent with this proclamation are hereby repealed or amended accordingly.
